Item 1: RENOVATION AND REMODELING

**DMC Fire Protection Improvements FH 5-8** 

MATC Bid Reference #2022-008 - Project #2022202.02

#### **Background Information**

Previously, the Board approved lists of renovation and remodeling capital projects for budget years. The projects and funding plan were also approved as part of respective year budget approvals. This project will provide a continuation of the sprinkler system on floors 5-8. This will include a fire pump to provide appropriate pressure for the sprinkler heads throughout the Foundation Hall Building.

The Foundation Hall project will also provide life safety upgrades to the lighting system in Foundation Hall and the S Bldg. Currently Foundation Hall and the S Bldg. have emergency lighting powered by battery powered lighting systems. This project will provide new LED emergency lights throughout the facility the facility powered by emergency circuits provided from a new Life Safety Panel powered by the S bldg. generator.

Additionally, there are alternates to replace the west stairwell doors and frames on floors 5-7, one to create a raised opening in the 3<sup>rd</sup> floor to create higher ceiling area as you enter FH from the S Bldg, and replace the coiling door on the first floor into the loading dock with a double door along with replacing the first floor sectional door and frame between the entry and stairwell.

The contract recommended for approval below is for a single prime contract that pertains to the general construction for the previously mentioned areas.

Bid documents for the aforementioned work were prepared in accordance with Board policies and State regulations, and advertisements were placed in the Daily Reporter, the Milwaukee Courier and the Spanish Journal. The bids were opened on July 8, 2022 with the following results which include the Base Bid only.

#### REMODELING SPECIFIED AREAS & RELATED WORK (Comprehensive Single Prime)

•	Hunzinger Constr	\$ 1,735,000.00
•	Selzer-Ornst Co	\$ 1,499,984.00*

Proposals were evaluated, and the low qualified bid, as indicated by the asterisk, has met specifications. There were no challenges to the bid document or the manner in which the successful bidder was selected.

Positive action by the board on this item will authorize the issuance of a contract in the amount shown to the firm indicated by the asterisk.
