7 a. Chairperson's Report

 Reported she and Director Case attended the Association of Community College Trustees (ACCT) Leadership Congress on October 13 - 16. The theme was Advancing Diversity, Equity and Inclusion. Director Case gave some feedback on the conference.

 Reminded the board to register for the Wisconsin Technical College District Boards Association (WTCDBA) fall meeting and

- legal issues seminar, which was held virtually on October 28 and 29.
- Drew the attention of the board to MATC's 2021 Winter Commencement, which is being held in person on December 17 at the Fiserv Forum. Chair Olson encouraged the board to hold the date on their calendars and stated the venue allows for ample social distancing and masks will be required.
- Stated she is working with college designees on a redesigned board self-evaluation tool that is more useful to the board's overall development.
- Introduced Director Case to give the MATC Foundation Report.
   Director Case reported:
  - Five new MATC Foundation Board members were introduced at the meeting. They are:
     Deborah N Allen, DNA Network LLC; Chantel Byrd, ManpowerGroup; Carlo Cervantes, Molson Coors Beverage Company; Dave Megna, WEC Energy Group and Dayla Randolph, PhD, Advocate Aurora Health
  - The Foundation Board heard the annual presentation of the audit. CliftonLarsonAllen LLP performed the audit and issued a clean audit.
  - The Foundation Board participated in a strategy session and divided into four groups that review and discuss external communications including brochures, electronic communications, social media, print storytelling and donor communications.
  - There was a gentle reminder to District Board members to support MATC students through a gift made to the MATC Foundation.

#### 7 b. President's Report

#### Discussion Dr. Martin:

- Reported the college hosted the official unveiling of the inaugural MATC Community Art Collection titled "Breaking Through!" on October 6. Dr. Martin thanked Dr. Julie Ashlock and the Community Arts Committee for launching this program and all the artists who submitted work for the collection.
- Stated she was invited by the Black Student Union to attend their monthly meeting and was joined by the college's DEI Officer, Eva Martinez-Powless. Dr. Martin listened to the concerns of the students and gathered ideas for additional ways the college can support their needs.
- Announced the college is in year five of the ten-year Guided Pathways implementation. Vice President of Institutional Effectiveness, Dr. Christine Manion, has begun an audit of key

- areas. The results will assist the college in identifying ways to improve the framework and provide for its long-term sustainability.
- Reported MATC was featured on the front page of the Thursday,
   October 21 Milwaukee Journal Sentinel for the expansion of its
   Promise program to adults who were delayed in completing high
   school. Eligible students who graduate from the college's Adult
   High School or earn a GED or HSED credential will be able to
   apply to attend MATC with tuition fully covered. Dr. Martin thanked
   Sara Cappaert, Jonathan Feld, Holly Thielen and Vasana Her for
   their hard work and Ginny Gnadt for her work on the publicity.

# 7 c. District Student Senate Report

#### Discussion

Mr. Erich Zeimantz introduced Mr. Phong Nguyen who:

- Reported Student Life has a theme of the month each month. This
  month's theme brings the students together and provides
  awareness of diverse groups, cultures and advocacy topics.
- Stated Student Life has improved the Student Union by increasing the number of games, decorations and hands-on events. These improvements highlights the care MATC has for its students, their mental health and wellbeing.
- Expressed his appreciation for the staff and faculty who have been very helpful to him and other students since the beginning of the year, making MATC feel like a second home to them.

# 7 d. Diversity, Equity and Inclusion Report

#### Discussion

Eva Martinez-Powless, Chief Diversity, Equity and Inclusion (DEI) Officer, presented the DEI Report. Ms. Martinez-Powless stated the first phase of the President's Task Force on Diversity, Equity and Inclusion is to perform an audit on all equity and inclusion activities. The college recently deployed three audit workgroups that will engage in the audit of equity and inclusion activities across the college. The groups are Instruction/Assessment, Student Experience and Employee Experience. Their role is to work in collaboration to tell the MATC story pertaining to diversity, equity and inclusion.

#### 7 e. Enrollment Report

#### Discussion

Dr. Naydeen Gonzalez-De Jesus, executive vice president, Student Success, presented the Enrollment Report. Dr. Gonzalez-De Jesus stated she formed a Strategic Enrollment Management (SEM) team that is charged with the responsibility of creating an integrated and comprehensive Strategic Enrollment Management Plan. The plan provides a foundation by which the college can begin to measure its enrollment efforts in alignment with Transformations 2025. Dr. Gonzalez-De Jesus introduced Dr. Sarah Adams, interim vice

president, Enrollment Management; Dr. Jeff Janz, vice president, Completion and Retention and Ms. Jenny McGilligan, director, Student Employment, Career and Transfer to present the Enrollment, Recruitment, Retention and Completion with a focus on next steps portion of the report. The written report and SEM Plan booklet was sent to the board prior to the meeting.

# 7 f. Milwaukee PBS VP General Manager's Report

# Discussion Mr. Bohdan Zachary:

- Reported the October 2 showing of Milwaukee PBS presents live from Bradley Symphony Center the Milwaukee Symphony Orchestra special received huge ratings. The television special was also streamed at Milwaukeepbs.org. The special was also geo filtered and was seen by viewers in Portugal, Ireland, Finland, United Arab Emirates, China, Germany and the Netherlands.
- Announced the Milwaukee Symphony Orchestra 90 minute special will air nationally on PBS on December 17.
- Stated a documentary titled "America's Dairyland at the Crossroads" will premiere on Thursday, November 18. Ahead of the television broadcast, The Rotary Club will feature Milwaukee PBS producer Maryann Lazarski and Milwaukee Journal Sentinel reporter Rick Barrett at a Rotary event on November 16.

#### 7 g. Legislative Matters Report

#### Discussion

Ms. Janice Falkenberg, vice president and General Counsel, introduced Ms. Ramie Zelenkova, lobbyist, Hubbard Wilson & Zelenkova, who presented the Legislative Matters Report on recent legislative matters impacting higher education, such as:

- Wisconsin Assembly Bill 195/Senate Bill 323 to designate
   University of Wisconsin and technical college sports and athletic
   teams based on sex of the participants. Passed Assembly 59 -38.

   Was not recommended for passage by Senate Committee (2-3).
   The Governor indicated he will veto the legislation if it reaches his
   desk.
- Wisconsin Assembly 414/Senate Bill 410 to prohibit sex and race stereotyping in training provided to employees of local and state government. Passed Assembly 60-38. Senate action pending. Governor indicated he will veto legislation if it reaches his desk.
- Fixing Foundations Housing Initiative Legislative Republicans circulated a package of legislation aimed to improve affordable housing highlights include:
  - Updates to Zoning and Permitting Processes and certification of shovel-ready projects.

- o Pay for performance grants for homeless initiatives.
- Federal-The American Association of Community Colleges is reporting that American's College Promise Act will be excluded from the Build Back Better Act currently being debated by Congress.

#### Information

Ms. Falkenberg, and Dr. Josie Veal, Public Health Officer, presented the COVID-19 Health and Safety Update and COVID Risk Mitigation Strategies via slides. Some highlights discussed in this report included COVID-19 Cases: MATC Dashboard and employee vaccination rate (the vaccination rate among active employees is 81%).

Dr. Veal spoke to the vaccination goal, which is to encourage the completion of a vaccination series among all eligible groups and promote COVID-19 booster doses.
